**Re: Devil's Swamp, East Baton Rouge Parish, Louisiana**

Dear Mr. Raymond:

We write to you today regarding a matter of grave importance to the African-American families who routinely eat fish contaminated with PCBs, hexachlorobenzene (HCB), and hexachlorobutadiene (HCBd) at levels 60-90 times what the government says are safe as a direct result of your and other companies' activities. We call upon you to stop obstructing cleanup of these hazards and to start providing alternative food to the families until the threats posed by Devil's Swamp Lake are abated.

As you know, Exxon Corporation and Exxon Chemical Corporation are two of eleven member companies that make up NPC Services, Inc. (NPC). NPC was formed to clean up the contamination at the Petro Processors Superfund site in East Baton Rouge Parish, Louisiana. The U.S. Environmental Protection Agency (EPA) has named its member companies as responsible parties at the site. The site is one of the worst in the country, especially because it has contaminated the fish in the Devil's Swamp Lake to the point that they pose an unacceptable risk to subsistence fishermen who depend on their catch to feed their families.

Rather than cooperate in cleaning up the site, NPC and its member companies have engaged in a long battle of attrition, raising arcane technical objections at every turn that have stymied any significant progress toward eliminating these threats. On March 8, 2004 EPA proposed to list Devil's Swamp Lake, a man-made lake in the middle of Devil's Swamp and adjacent to the Petro Processors site, to the Superfund National Priorities List (NPL) in order to begin cleanup of the chemicals that pollute the watershed and poison

its fish. NPC opposed the listing, as it did nearly ten years ago, this time adding to its arsenal of obstructions a challenge under the Information Quality Act (IQA).

Enclosed please find the Center for Progressive Regulation's (CPR) response to NPC's IQA petition. CPR's letter calls upon EPA to immediately finalize the listing of Devil's Swamp Lake. The letter also asks EPA to order responsible parties to provide groceries to the affected communities pending cleanup of the lake, so that they no longer face the choice of endangering their health or going hungry. Companies are routinely ordered to provide alternative water to communities facing similar hazards, and EPA has ample authority under the Comprehensive Environmental Response Compensation and Liability Act (CERCLA or Superfund) to order the provision of alternative food supplies.

Today we call upon you to live up to Exxon's humanitarian and legal obligations by voluntarily providing groceries to the families that are at risk as a direct result of Exxon's waste disposal and delay tactics. Cleanup of the Devil's Swamp watershed is decades past due, and even if EPA finalized listing tomorrow, will not be complete for many years to come. We sincerely hope you will provide that protection by offering groceries to those in need.
